I hereby further agree to indemnify and to hold forever harmless the said Releases from any and all claims, loss, liability, damage, or cost Releases may incur due to my and or my child presence in Hines Creek while utilizing the above-described race track facilities, and/or participating in and/or observing said Soap Box Derby races and/or events. I hereby assume all responsibility for and risk of bodily injury, death, or property damage due to any act or omission of Releases while so I, or my child, is utilizing the above described race track facilities and/or participating in and/or observing said Soap Box Derby races and/or events. I expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the Village of Hines Creek and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and legal effect.
